Even while most libraries in Illinois are experiencing facilities closures due to the COVID-19 pandemic, the library community have come together to design and expand services that do not require the public to enter the building. After the issuance of Executive Order 2020-32 on April 30, 2020 by Governor J.B. Pritzker, library boards and governing bodies have considered providing services that they consider essential, such as curbside delivery of library materials. Because of staffing, hours of service, and library collection limitations when implementing these temporary service models, a library may need to restrict access to their own patrons. Recognizing this need, the Secretary of State and the Illinois State Library filed an emergency rule effective May 7, 2020 to temporarily suspend resource sharing, reciprocal borrowing, and interlibrary loan requirements for library system membership in the Illinois Library System Act (23 III.
