EBSCO Group Purchase Year 3 Statistics

September 2023


Olivia Montolin has compiled an analysis specifically comparing the second and third years of the ESBCO group purchase. Year 2 statistics (July 2021 through June 2022) includes 84 public libraries that participated in the second year of the group purchase. Year 3 statistics (July 2022 through June 2023) includes the same 84 public libraries that remained in the group purchase. The increase from Year 2 (391,975) to Year 3 (519,159) is 32%, while the overall increase from Year 1 (255,026) to Year 3 (519,159) is 51%.

All statistics reflect "Total Item Investigations", which is a download of a full-text article. Consumer Reports and Auto Repair Source statistics use "Sessions" which is a log-in and use of the resource. These metrics are the closest equivalent to a checkout of a physical item; there is also the option to measure clicks, which would provide much higher numbers, but the metrics represented here give the truest picture of use.

A major goal of the SWAN EBSCO group purchase was to provide a set of standard reference resources for all SWAN libraries, especially as many libraries are focusing physical collection development efforts around popular resources. In the pie chart above, you can see that the "other" category — which includes resources less than 2% of total usage, totaling 49,159 uses. This usage is higher than Consumer Reports or Novelist K-8, consistent with previous years analysis. This continues to be a major advantage

of a group purchase bundle: For the cost of a few popular resources, the vendor includes additional niche resources that, in aggregate, find more use than some popular resources. Also of note is that academic resources found a significant amount of use and grew in usage from Year 2 to Year 3 with Academic Search Premier and Complete being the most used databases with 23% overall usage. Consumer Reports, Novelist Plus, and Novelist K-8 also all increased during Year 3.

Cost-per-use continued to drop between EBSCO Year 2 and EBSCO Year 3. Included in the chart below is the Cost-per-use for all three years. A steady decrease in cost-per-use is evident, with EBSCO Year 3 dropping below \$1.00.

While circulation of physical items and database use is not a one-to-one comparison, we have also included the estimated cost-per-use of books SWAN-wide based on item type and item cost under \$100 to eliminate incorrect price data and high-cost items, such as library-of -things materials, that may have a high cost-per-use.
