Vox and other Read-alongs

- Following a discussion with the Cataloging Advisory Group, SWAN has decided that these materials are primarily audio materials rather than print. This is consistent with the majority of catalog records on OCLC.
- Catalog records should follow audiobook conventions. Use Record Type "i" (Leader 006/00) for Non-Musical Sound Recording.
- In the absence of an OCLC record for Sound Recordings, you can choose to derive the book record and create the sound recording record, or update an existing RecType "a" record to be RecType "i", which would involve changing up the entire fixed field before import.
